



เศรษฐกิจบราซิล Q1/2565

- GDP บราซิล Q1/65 ขยายตัว 1.5% YoY และ 1.0% QoQ
- Q1/65 การส่งออกสินค้า มูลค่า 72.6 Bn USD ขยายตัวถึง 30.4% YoY และ 7.5% QoQ การนำเข้าสินค้า มูลค่า 60.5 Bn USD ขยายตัวถึง 27.2% YoY แต่หดตัว 3.3% QoQ ส่งผลให้ดุลการค้า เกินดุล 12.1 Bn USD เกินดุลเพิ่มขึ้นจากช่วงเดียวกันของปีก่อน และไตรมาสก่อน หากพิจารณา 4M/65 การส่งออกสินค้า มูลค่า 101.4 Bn USD ขยายตัวถึง 24.1% YoY การนำเข้าสินค้า มูลค่า 81.3 Bn USD ขยายตัวถึง 27.6% YoY ส่งผลให้ดุลการค้า เกินดุล 20.2 Bn USD เกินดุลเพิ่มขึ้นจากช่วงเดียวกันของปีก่อน
- ดัชนีราคาผู้บริโภค (CPI) Q1/65 ขยายตัว 10.7% YoY และ 2.6% QoQ หากพิจารณา 4M/65 ขยายตัว 11.1% YoY
