

เศรษฐกิจกลุ่มประเทศยูโร Q1/2565

- GDP กลุ่มประเทศยูโร Q1/65 ขยายตัว 5.4% YoY และ 0.6% QoQ
- Q1/65 การส่งออกสินค้า มูลค่า 743.3 Bn USD ขยายตัว 8.6% YoY แต่หดตัว 1.3% QoQ การนำเข้าสินค้า มูลค่า 801.8 Bn USD ขยายตัวถึง 30.0% YoY และ 5.0% QoQ ส่งผลให้ดุลการค้า ขาดดุล 58.4 Bn USD เปลี่ยนสถานะจากที่เกินดุลในช่วงเดียวกันของปีก่อน แต่ขาดดุลเพิ่มขึ้นมาจากไตรมาสก่อน
- ดัชนีราคาผู้บริโภค (HICP) Q1/65 ขยายตัว 6.1% YoY และ 2.2% QoQ หากพิจารณา 4M/65 ขยายตัว 6.5% YoY

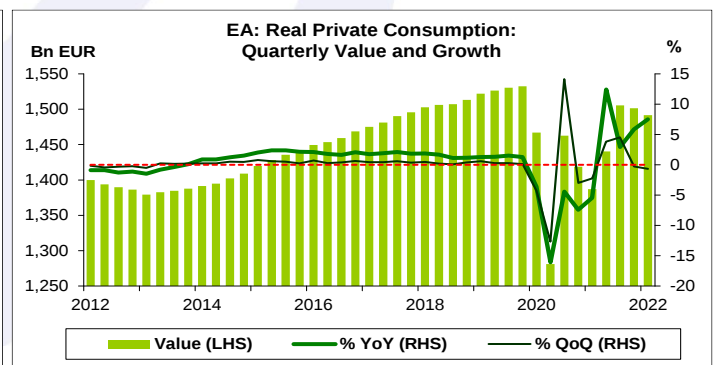
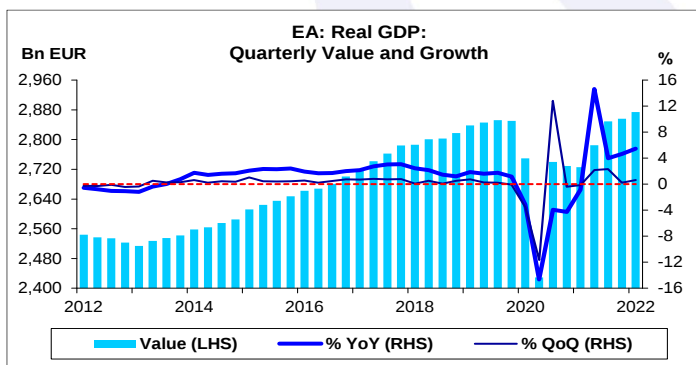

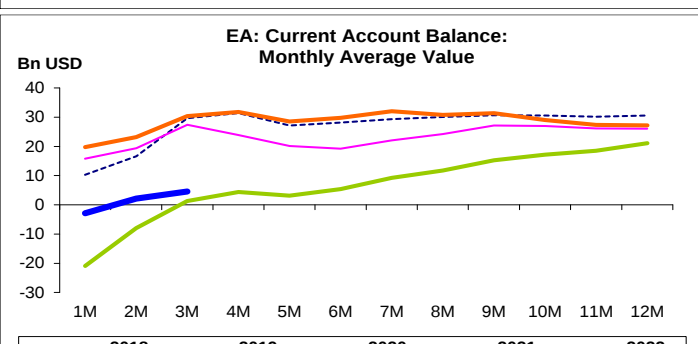
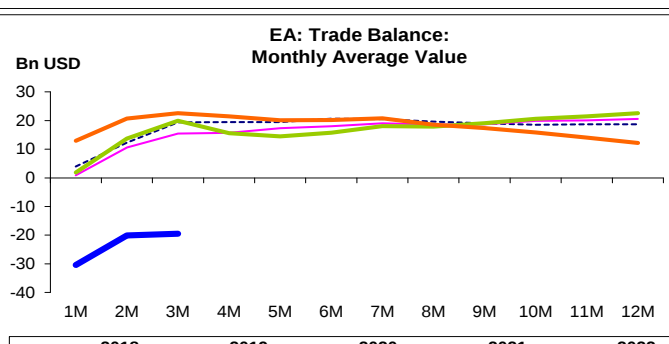
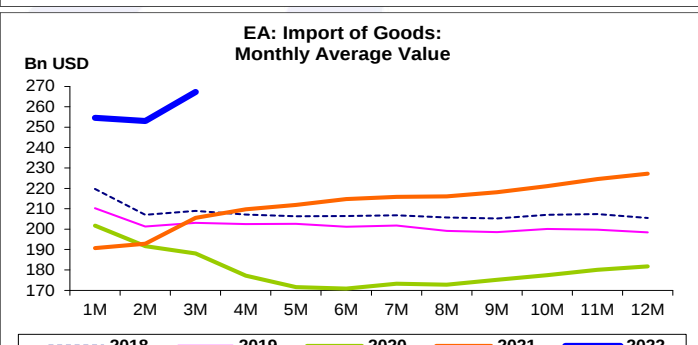
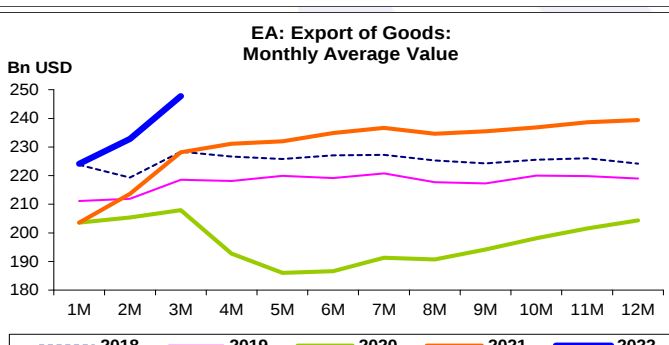
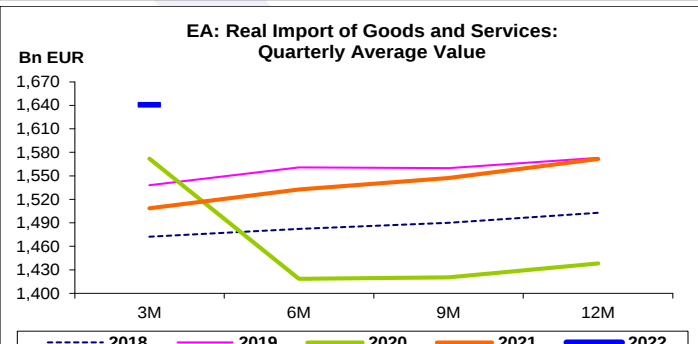
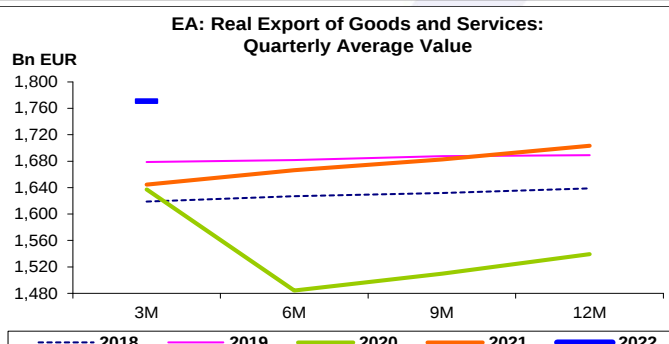
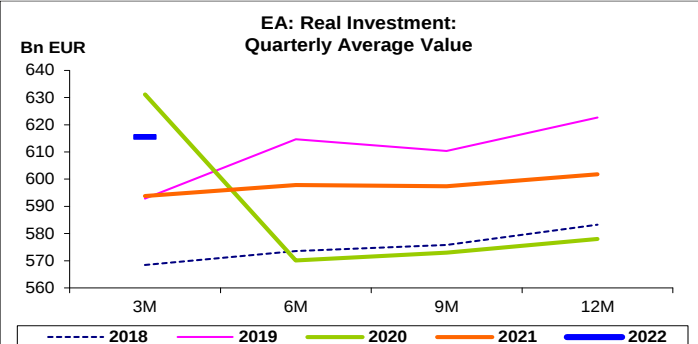
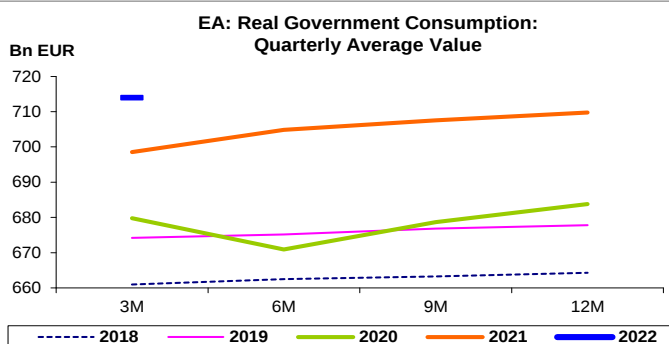
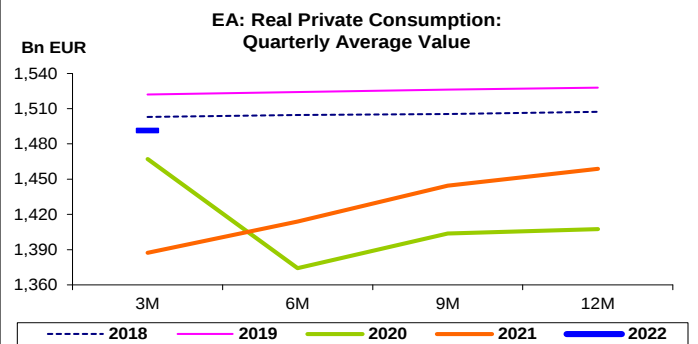
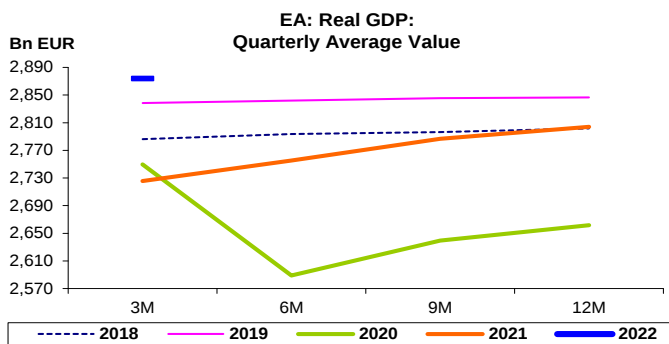






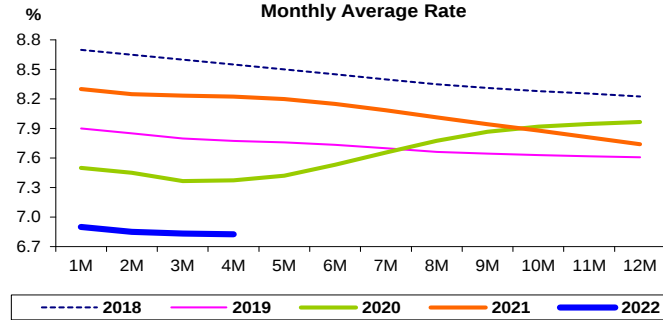




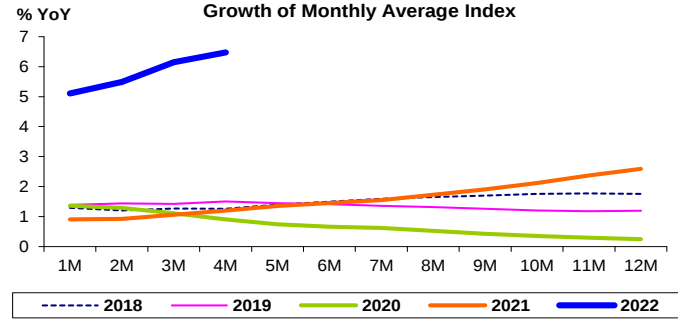




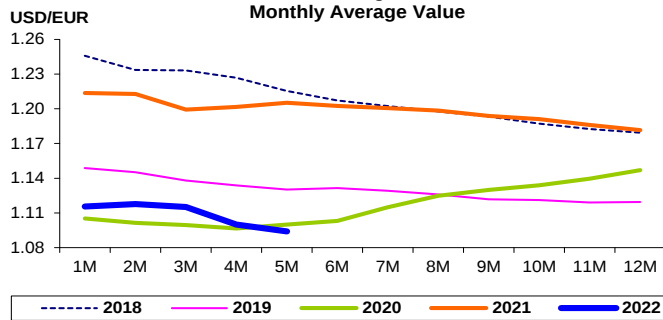
EA: Unemployment:
Monthly Average Rate



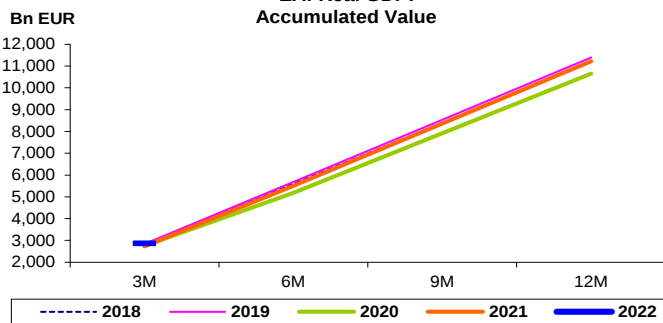
EA: Harmonized Consumer Prices:
Growth of Monthly Average Index



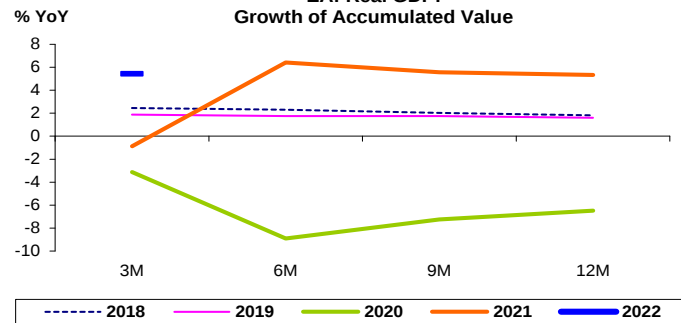
EA: Exchange Rate:
Monthly Average Value



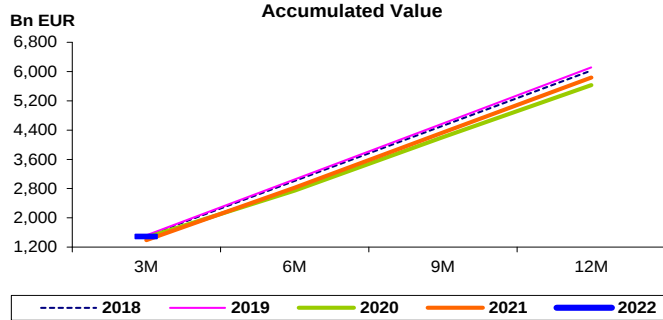
EA: Real GDP:
Accumulated Value



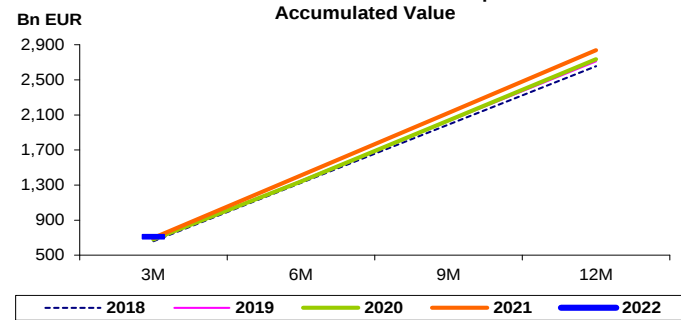

Growth of Accumulated Value



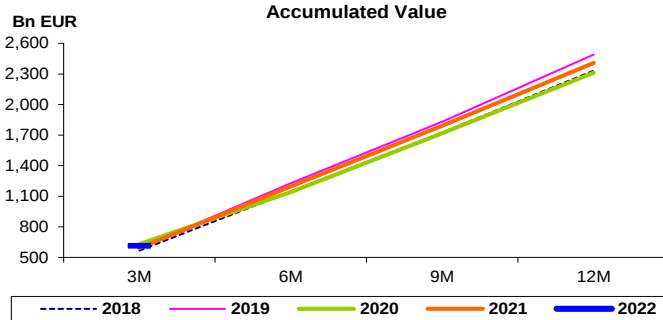

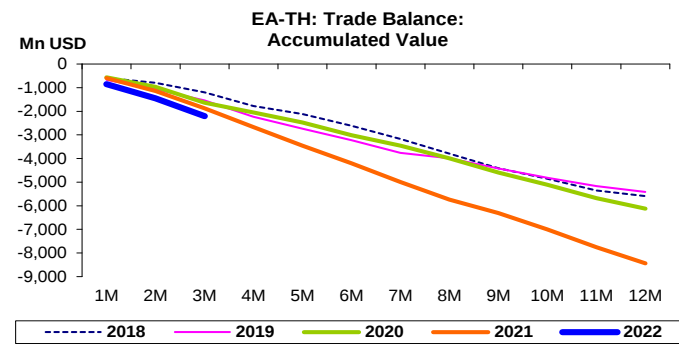
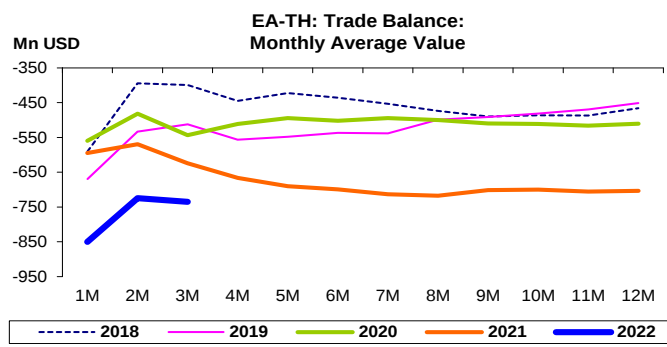
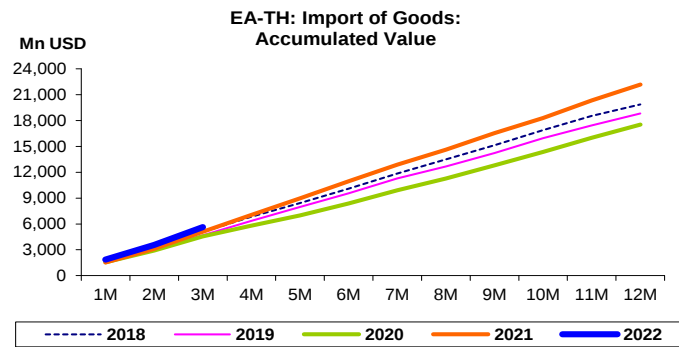
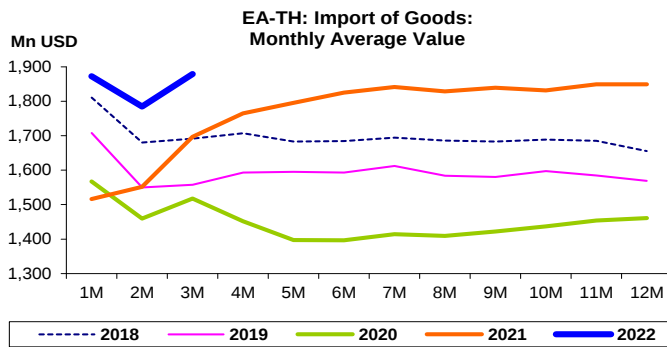


EA: Real Export of Goods and Services:
