

เศรษฐกิจเยอรมนี Q2/2564

- GDP เยอรมนี Q2/64 ขยายตัว 9.4% YoY และ 1.6% QoQ หากพิจารณา 6M/64 ขยายตัว 2.8% YoY
- Q2/64 การส่งออกสินค้า มูลค่า 410.9 Bn USD ขยายตัวถึง 47.1% YoY และ 2.6% QoQ การนำเข้าสินค้า มูลค่า 356.6 Bn USD ขยายตัวถึง 42.5% YoY และ 6.3% QoQ ส่งผลให้ดุลการค้า เกินดุล 54.3 Bn USD เกินดุลเพิ่มขึ้นมากจากช่วงเดียวกันของปีก่อน แต่เกินดุลลดลงมาจากไตรมาสก่อน หากพิจารณา 6M/64 การส่งออกสินค้า มูลค่า 811.4 Bn USD ขยายตัวถึง 27.4% YoY การนำเข้าสินค้า มูลค่า 692.1 Bn USD ขยายตัวถึง 25.7% YoY ส่งผลให้ดุลการค้า เกินดุล 119.3 Bn USD เกินดุลเพิ่มขึ้นมากจากช่วงเดียวกันของปีก่อน
- ดัชนีราคาผู้บริโภค (HICP) Q2/64 ขยายตัว 2.2% YoY และ 1.3% QoQ หากพิจารณา 7M/64 ขยายตัว 2.1% YoY
